

Fingerprinting Procedures for Concealed Carry License

- ❖ Register at <https://nm.state.identogo.com>
- ❖ Select "schedule a new appointment"
- ❖ Enter corresponding ORI information:
 - NM920200Z for civilian \$59.00
 - NM920272Z for military or law enforcement \$23.00
- ❖ Privacy act statement
- ❖ Enter zip code
- ❖ Select preferred available time
- ❖ Enter applicant information
- ❖ Review info and continue to pay screen
- ❖ Print or record receipt for use at scheduled appointment
- ❖ Fingerprint location will provide a TCN Number after you are fingerprinted



Examples of Documents

Idemia (IdentoGo) Fingerprint Receipt must include the TCN (Transaction confirmation number “TCN”)

Form with only registration number is not the fingerprint receipt
